

# AMENDMENT TO THE FISHING REGULATIONS AND TO REGISTER OF FISHERIES

for holders of regional fishing permits for non-salmonid and salmonid waters Valid for the year 2022

Part III. of the fishing permit

### Amendments to the Fishing Regulations of the Czech Anglers Union, West-Bohemia Regional Board - 2022

#### Exceptions for burbot and ide fishing:

Based on the decision No. KUUK / 3229 / ZZ / 20-14 of 9 November 2020 issued by the Regional Office of the Karlovy Vary Region, Department of the Environment and Agriculture, the killing and possession of ide (Leuciscus idus) and burbot (Lota lota) are prohibited in all fisheries of ČRS, z. s., Zpč. ÚS in the territory of the **Karlovy Vary region**.

# Amendments to the Register of Fisheries of the Czech Anglers Union - West-Bohemia Regional Board - 2022

#### Modifications:

433 901 Otava 8 A – GPS of Pěkný potok: 49°7'47.096"N, 13°29'52.308"E

#### Additional fisheries:

**05 431 138 LOUČKY – LO Loket nad Ohří** *GPS 50 °12'13.04"N. 12 °45'20.85"E* 

0.436 ha

The fishery consists of the pond U Porcelánky in the cadastral territory of Loučky u Lokte 0.436 ha.

Entering by all vehicles through the grounds of the Rudolf Kämpf porcelain factory is prohibited. The only allowed access is by the footbridge over Loučkovský stream at the playground!

#### 421 503 TRNAVA – ÚDOLNÍ NÁDRŽ TRNÁVKA ČRS Council

10,2 km 83 ha

Keeping of fish in containers or fish cages is prohibited.

#### 441 501 VESLAŘSKÝ KANÁL RAČICE ČRS Council

50 ha

When angling with bait fish, only the whole fish with minimum allowed length of 15 cm may be used. The minimum allowed length of all fish, with the exception of those the minimum length of which was stated higher by the by the Decree No. 197/2004 Coll., is 15 cm. This provision is valid for bait fish as well. The maximum length of common carp is 70 cm. A caught carp over 70 cm (inclusive) must be released without delay and with maximum respect back into the fishery where it was caught. Keeping of fish containers or fish cages is prohibited. Ice fishing through ice holes allowed from December 1st, 2021 to March 10th, 2022 and from December 1st, 2022 to March 10th. 2023.

## 481 501 VLTAVA 16 – 19, ÚDOLNÍ NÁDRŽ ORLÍK 55,5 km 2 300 ha ČRS Council

Keeping of fish in containers or fish cages is prohibited. Nonstop fishing allowed from June 16th, 2022 to September 30th, 2022 from 00.00 to 04.00 o'clock.

Exceptions for 24-hour fishing for the period from June 16th to September 30th in 2022 and 2023 are valid in the following fisheries:

#### 431 028 Mže 4, 431 040 Ohře 19, 431 043 Radbuza 1 B and 431 059 Teplá 2

Based on the conditions of this decision and in accordance with the Article 13 paragraph 9 of Act No. 99/2004 Coll., the ÚS ČRS added the following provisions as detailed conditions for the exercising of fishing rights in the fisheries concerned:

- a) In the period from September 1st to September 30th between 00.00 and 04.00 o'clock only baits of vegetable origin or bait fish with minimum length of 15 cm can be used; the bait fish must be used as a whole; it is prohibited to use only its parts.
- b) An angling person is required to illuminate the place of angling by a non-dazzling white light at the time from 00.00 to 04.00. Making of open fires for these purposes is prohibited.
- c) In case of continuation of angling after 24 o'clock, the angling person is required to record the new date of angling and number of fishery into Part II of the fishing permit (Record of Fishing and Catches) in an indelible way. If the angling person has not kept any caught fish on the

previous day he/she is required to cross through the blank line of that date, at the latest before writing the new date.
