

Amendment to the Fishing Regulations

The detailed conditions for the performance of the Act on Fishery, § 13, paragraph 9, Act No. 99/2004 Coll., have been amended:

The catch of tench (*Tinca tinca*) in both salmonid and non-salmonid fisheries is **limited to 4 pieces a day**.

VII. Conduct when angling

Hooking of fish in other parts than in mouth is prohibited.

Amendment to the Register of Fisheries

04 231 001 BONĚTICKÝ RYBNÍK – Klatovské rybářství, a. s. 32 ha Amendment to the fishery description: Angling in the premises of the company LUKON Bonětice s.r.o. is allowed only after receiving a permission of the user of the premises.

431 118 ČERNÝ POTOK 1/R – LO Poběžovice

0.6 ha

The reservoir Mračnice forming the fishery was removed on the owner's request.

431 017 KOSOVÝ POTOK 3 – LO Mariánské Lázně

15 ha

The subfishery PR 03 (Skláře 0.5 ha) was removed on the owner's request.

431 098 MERKLÍNKA 2/R - LO Srbice

0.6 ha

The subfishery PR 03 (Požární nádrž 0.15 ha) was removed on the owner's request.

431 039 OHŘE 18 - LO Cheb

14 km 17.2 ha

The subfishery PR 04 (Vojtanovský 0.5 ha) was removed on the owner's request.

The subfishery PR 01 (Starý rybník 3.6 ha) became a part of the fishery 431 101 Ohře 18/R as the subfishery PR 04.

431 041 OTAVA 5 A – LO Horažďovice

11 km 32 ha

Spawning grounds of grayling (*Thymallus thymallus*) may be marked in this fishery (*Thymallus thymallus*). In the marked spawning grounds wading is prohibited in the time from April 16th to May 31st

04 233 001 OTAVA 6 - Klatovské rybářství, a. s.

4.6 km 5 ha

The fishery was removed on the owner's request.

431 048 RADBUZA 3 A - LO Stod

30 ha

Non-stop angling: Based on the Decision ref. No. 28638/2017-MZE-16232, the West Bohemian ÚS ČRS was granted an exception from the times of angling for this fishery for the period from June 16th to August 31st 2018 and from June 16th to August 31st 2019 between 00.00 and 04.00 o'clock.

Following the conditions of the decision and in accordance with the meaning of Art. 13, paragraph 9 of the Act No. 99/2004 Coll., the West Bohemian ÚS ČRS added further detailed conditions for exercising of fishing rights in the fishery concerned by the following provisions:

- a) The angling person is obliged to illuminate the angling place by white glare-free light in the time from 00.00 to 04.00 o'clock. Establishing of open fires for these purposes is prohibited.
- b) When continuing angling after 24 o'clock, the angling person is obliged to record a new date of angling and number of the fishery into the Part II of the angling permit (Record of Fishing and Catches) in an indelible way. If the angling person has not kept any caught fish on the previous day he/she is obliged to cross through the blank line of that date, at the latest before writing the new date.

421 503 TRNAVA – ÚDOLNÍ NÁDRŽ TRNÁVKA

10.2 km 83 ha

When angling with bait fish, only a whole bait fish may be used, its minimum length being 15 cm. Minimum required length of all fish species, except those the length of which was stated higher by the Decree No. 197/2004 Coll., is 15 cm. This provision is valid even for the live bait fish preserved for angling.

431 065 ÚHLAVA 2 - LO Štěnovice

10 km 21.6 ha

The subfisheries PR 04 (Jezírko 0.4 ha) and 05 (Šíp 1.0 ha) were removed on the owner's request.

433 061 VERNÉŘOVSKÝ POTOK 1 – LO Aš

18 km 2.4 ha

The reservoir Bílý Halštrov 6.6 ha has been removed from the fishery since 2018.

441 501 VESLAŘSKÝ KANÁL RAČICE – ČRS Council

50 ha

When angling with bait fish, only a whole bait fish may be used, its minimum length being 15 cm. Minimum required length of all fish species, except those the length of which was stated higher by the Decree No. 197/2004 Coll., is 15 cm. This provision is valid even for the live bait fish preserved for angling.

Ice fishing

Based on the decision of the Regional Authority of the Region of Ústí, Department of Environment and Agriculture, Ref. No. 1525/ZPZ/2017-5 dated April 20th, 2017, the ČRS Council was granted an exception from the prohibited methods of fishing - ice fishing - in the fishery No. 441 501, Rowing Channel Račice, for the time from December 1st 2017 to March 11th 2018.

481 501 VLTAVA 16 – 19, ÚDOLNÍ NÁDRŽ ORLÍK –

ČRS Council 55.5 km 2300 ha

When angling with bait fish, only a whole bait fish may be used, its minimum length being 15 cm. Minimum required length of all fish species, except those the length of which was stated higher by the Decree No. 197/2004 Coll., is 15 cm. This provision is valid even for the live bait fish preserved for angling.

Non-stop angling:

Based on the Decision ref. No. 28549/2017-MZE-16232 dated June 8th, 2017, the ČRS Council was granted an exception from the times of angling for this fishery for the period from June 16th to August 31st, 2018 and from June 16th to August 31st, 2019 between 00.00 and 04.00 o'clock, and for the period from September 1st to September 30th 2018 and 2019 between 22.00 and 24.00 and 00.00 and 06.00 o'clock.

The conditions of angling during the time of the exception granted were complemented in the following way:

- a) The angling person is obliged to illuminate the angling place by white glare-free light in the period from June 16th to August 31st between 00.00 to 04.00 o'clock and from September 1st to September 30th between 22.00 to 06.00 o'clock. Establishing of open fires for these purposes is prohibited.
- d) In the period from September 1st to September 30th 2018 and 2019 between 22.00 and 24.00 and 00.00 and 06.00 o'clock, the bait used may be of vegetable origin only or a whole bait fish (not just parts of it) with minimum length of 20 cm. So called boilies or pellets, a part of which may consist of inhomogeneous components of animal origin, are considered as baits of vegetable origin. (The conditions given and valid in September are based on the requirements of the Ministry of Agriculture due to the protection of European eel (Anguilla anguilla).
